FOR ALL CANDIDATES REPORTING TO BMCRI

Physical reporting to the college is mandatory for all students who have been allotted PG seat in BMCRI. This is applicable to:

1. Candidates allotted PG seat in BMCRI in 2nd round of AIQ, and wish to join the allotted seat.
2. Candidates who were allotted PG seat in BMCRI in 1st round of AIQ, not going for up gradation, and willing to continue with the same seat. Even if such candidates have earlier joined by virtual/offline mode, physical reporting is a must.
3. Candidates joining PG seats at BMCRI through State quota (1 & 2 rounds) **(For state quota candidates, date of reporting will be announced later, but rest of the instructions remain same)**

Date of reporting **for AIQ candidates**: 16th – 30th June 2020

Time: **10:30 AM to 3:30 PM**

Place of reporting: **Old Examination Hall, First floor (above dissection hall), Library block, BMCRI**

Note: Only one person may accompany the candidates coming for PG admission.

Candidate and accompanying person shall enter the campus only through **GATE No. 2** and proceed straight to the admission center. Once procedure is completed they shall leave by the same gate. They shall not enter any other room/block. Unnecessary wandering about the campus is strictly prohibited. These restrictions are important to ensure safety of yourself as well as others.

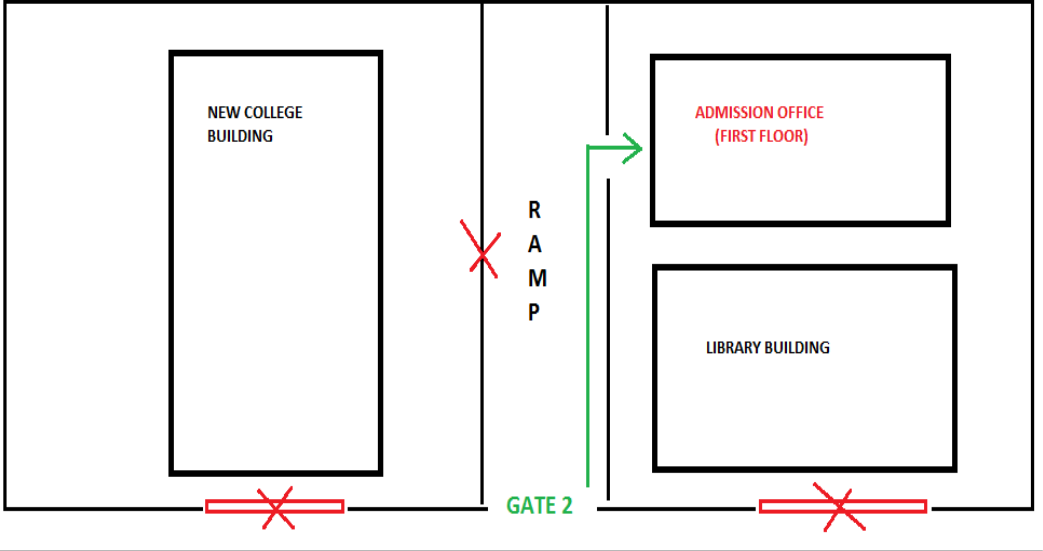
